FEMA Grant Update – split into 3 projects.

- 1. Coyote/Nature road repair; \$6,293.32; Liberty Twp received \$6,135.99 on 12/8/22.
- 2. Old Long Lake/Mosey 2 culverts; \$9,656.67; Liberty Twp received \$9,415.25 on 1/12/23.
- 3. Oliver Culvert Final expenses and payment confirmation has been submitted to FEMA. Liberty Twp is seeking reimbursement of \$15,118.09. FEMA may ask that adjustments to withdraw some of the early temporary repair expenses. Sup. Oestreich will follow up with FEMA.

Township Election is scheduled for March 14, 2023. Election judges will be Alva Drusch, Connie Petrie and Shirley Curtis.

NEW BUSINESS

Rural Fire Association – their levy is being increased by \$70,000. Most of their equipment has a lifespan of 20 years and replacement is scheduled on a staggered rotation for a major expense every 4 years. A fire district model is being considered instead of the current administrative structure.

Road Improvements - Supervisors discussed long range plans for roads. Old Long Lake, West from Cnty Rd 9 is one area that may need a phased reconstruction to spread out expenses.
